Description: A blend of highly refined mineral oils with multifunctional additives.

4. FIRST AID MEASURES:

General Information: No special measures required

After inhalation: Supply fresh air; consult doctor in case of complaints.

After skin contact: Immediately wash with water and soap and rinse thoroughly. If skin irritation continues, consult a doctor.

After eye contact: Check for and remove any contact lenses. Rinse opened eye for several minutes under running water. Then consult a doctor.

After swallowing: Wash mouth out with water. Do not induce vomiting; call for medical help immediately.

Information for doctor: High pressure injection injuries through the skin require prompt surgical intervention and possibly steroid therapy, to minimise tissue damage and loss of function. As entry wounds are small and do not reflect the seriousness of the underlying damage, surgical exploration to determine the extent of involvement may be necessary. Local anaesthetics or hot soaks should be avoided because they can contribute to swelling, vasospasm and ischemia. Prompt surgical decompression, debridement and evacuation of foreign material should be performed under general anaesthetics and wide exploration is essential.

5. FIRE FIGHTING MEASURES:
